

ISO 14001 is an international set of standards that specifies the requirements to plan, implement, establish, operate, monitor, review, maintain, and continually improve an environmental management system. Also, it helps organizations to adequately prepare, respond and manage the consequences of environmental degradation and legal liabilities stemming as a result of it.

participation in a value chain.


This is important as many public and private sectors are making it a standard requirement for those it works with.

Who Should Get ISO 14001:2015 Certification?


ISO 14001 can be used by any organization that desires to set up, enhance, or maintain an environmental management system to conform with its established environmental policy


