In November 2006, ISO 44001 was created as PAS 11000 Collaborative business connections. It was designated as a British Standard, BS 11000, in 2010, and it has since expanded into an international standard to assist businesses in developing effective competitive business partnerships based on a collaborative approach. The norm applies to all sizes of private and public organizations, from major multinational enterprises and government agencies to non-profits and micro/small businesses. It may be used to manage connections at several levels, whether your requirements are for a single application across operational divisions or for more complicated collaborations such as consortia and joint ventures.


